No additional compensation shall be allowed by reason of any misunderstanding or error regarding the conditions/layout of or work to be performed at the offices.

Impromptu questions will be permitted at the Pre-Bid Tele-Conference and verbal answers will be provided. Verbal answers provided. Verbal answers provided by the HPHA are not binding and only intended as general guidance purposes. Formal written responses to substantive questions will be provided to each registered interested bidder as set forth in Section VI below. All changes to the IFB will be issued as an addendum to the IFB.”
